



**MINOR TRAVELERS SAILING WITHOUT A LEGAL GUARDIAN**

Please take into account the following guidelines:

- Guests must be 18 to travel. Guests under the age of 18 must be accompanied by an adult who is the parent, relative, legal guardian of the minor, and/or have the express written permission of the minor's parent or guardian allowing travel.
- The legal drinking age is 21 in U.S. waters and 18 at sea and is strictly enforced. We do not permit the purchase of bottles of liquor by any minor.
- Guests under the age of 18 years must have adult supervision.
- Possession of alcohol by a minor will not be tolerated and any found will be confiscated.
- Purchase, possession and/or consumption of drugs are illegal.
- No abusive, offensive or vulgar language or behavior should be directed to other guests or to staff and crew.
- Large radios ("boom boxes") are not permitted onboard.
- Headphones must be used with radios on deck.
- No running on board the vessel.
- No noise in cabin areas or corridors.
